The **Distance Education Certification Program** establishes and monitors standards for instructional design and course delivery for real estate distance education courses.

The **International Distance Education Certification Center (IDECC)** utilizes the Distance Education Certification Program to meet the demand for distance education certification credentials in professions beyond real estate brokerage.

The **Education Award** annually recognizes excellence and innovation in education efforts.

The **Certified Distance Education Instructor (CDEI™)** is a credentialing program for individuals who teach distance education courses. This certification is required for all ARELLO and IDECC certified courses.

The **Examination Accreditation Program** ensures the validity and defensibility of licensing examinations, a critical requirement of regulatory agencies, by providing independent review and evaluation of licensing exams and the methodology used in their development.

The people and jurisdictions that we serve deserve committed advocates. ARELLO provides critical resources that allow our members to administer and enforce real estate license laws in ways that best promote and protect the public interest.

Our **License Verification Program** provides an instant report on the status of an individual's real estate license in almost every jurisdiction where he/she may hold a real estate license.

The **Disciplinary Action Data Bank** is an online database of individuals who have, at some point, been the subject of disciplinary action by a real estate licensing agency. This database consolidates disciplinary action by participating real estate regulatory agencies (available for viewing only by regulators).

The **Timeshare Registry** is a fast, secure, and efficient method for regulatory agencies to process timeshare registration filings entirely online, and at no cost to the agency.
